World Central Kitchen is reducing this number by converting school and home kitchens from charcoal to clean, gas-burning stoves while providing food safety and sanitation training to all cooks. Where gas is not available, we continue to implement new improved cook stoves.

Education - Education is the strongest way to advance the developing world, and a meal can often be the impetus for a child to go to school. World Central Kitchen supports education by providing clean school kitchens and supplementing healthy meals.
